- Maximum Child Tax Credit and maximum Working Tax Credit and your income is less than £6,420 per year
- Incapacity Benefit or Severe Disablement Allowance
- · Pension Credit
- Support under Part VI of the Immigration and Asylum Act 1999
- Universal Credit (When work earnings are below £610 p/m) or if your child:
- · Is looked after
- · Is under a kinship care order
- · Lives with a parent appointed guardian
